Origins and Accomplishments

History of MA Community Preservation Act (CPA)

MA CPA legislation and approval did not come easy. It took 18 years following the experience of Cape Cod Land Bank legislation, and finally drawing on a successful model from New Jersey.

Chronology of MA Land Bank and CPA Legislation

1983 - Nantucket Land Bank with 2% Real Estate Transfer Tax (RETT) approved by a MA Legislative Act.

1985 - MA Act giving RETT land bank authority to all towns fails due strong opposition from the National Association of Realtors.

1987 - MA Act with 1% RETT for land bank & affordable housing fails.

1997 - MA CPA with 1% RETT for open space, affordable housing, historic preservation and other purposes fails.

1998 - Cape Cod Land Bank Act with RETT fails at ballot (55% No).

1998 - CC Land Bank Act with 3% property tax surcharge approved by MA & CC (\$15 million startup from MA, 20 year life).

2000 - MA CPA with up to 3% property tax surcharge approved for open space, community housing & historic preservation.

2002 - Chatham Town Meeting adopts CPA with 3% surcharge by vote of 51% yes and 49% no.

2004 - MA CPA amended to allow merging of CC Land Bank into CPA but Chatham declined and continued both.

2012 - MA CPA amended to include outdoor recreation funding.

Chatham Land Bank Results

Over 20 year life received \$14,448,200 from property tax surcharge plus the initial State contribution.


From 1999 to 2017 Chatham spent \$13,755,979 on 23 open space land purchases totaling 150 acres

Land Bank local surcharge ended in 2019

Funds remaining for expenditure = \$692,221



Chatham CPA Application Process

- Online Application Form available at *chatham-ma.gov/562/Online-Application-Form*
- Any Town agency, organization, business or individual can apply
- Deadline for applications is November 1
- The Chatham Community Preservation Committee (CPC) reviews applications, usually meets with the applicants, sometimes does site visits, sometimes negotiates, prioritizes applications and for each recommends approval or decline.

Chatham CPA Approval Process CPC votes to recommend approval or to decline the application.

If a majority of CPC members vote to recommend:

- Draft warrant article is prepared
- Select Board casts non-binding vote
- Finance Committee casts non-binding vote

- Warrant article with votes goes to Town Meeting.

Town Meeting votes to approve or decline application.
